Data from the Online Information System for the Protection of Women and Children (Symphony PPA) from 2021 to March 17, 2022 shows, of the 8,478 cases of violence against women, 1,272 cases of which are sexual violence. Of the 11,952 cases of violence against children, 7,004 cases (58.6




Figure 1. Number of Sexual Assaults

On the basis of the various solutions and activities carried out above, it is necessary to carry out further assistance, and guidance for the community and youth groups related to the law on sexual violence crimes massively and comprehensively with a record of periodic socialization and
